PRACTICAL HOURS: 180 HOURS.

AIM

- Encourage education within an authentic club environment.

REQUIREMENTS

Activities may include:

- Observations: from outside the field.
- Internships: auxiliary interventions.
- Practical work: the student in the role of a coach.

Activities should be conducted in:

- Competitive and recreational football academies.
- Clubs affiliated in the country of residence.

The student is required to:

- Prepare in advance for choosing an institution.
- Seek approval to conduct the activities.
- Having fulfilled the required hours to gain access to the Final Exams.

CERTIFICATION

- The hosting entity is required to verify the hours worked.
- The certification must be submitted on the entity's letterhead. It should include the signature and position of the signatory, as well as the student's information, the hours worked, and the categories in which the work was performed.



INSTALLMENTS AND TIMELINES

FUNDAMENTAL PRINCIPLES

- 8 monthly payments (includes virtual and final payments).
- Individual value: 600 USD.

PAYMENT OPTIONS

From overseas: international remittance, credit or debit card.

- Payments processed through credit or debit cards are charged instantly.
